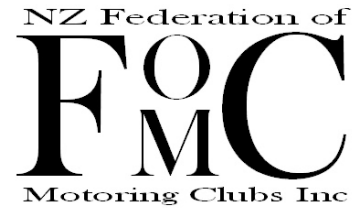


*Minutes of the 26<sup>th</sup> Annual General Meeting of the

**Morning speaker: George Kear** (Chief Operating Officer, [Auto Restorations](#), Christchurch) presented various aspects of the restoration business with a number of example vehicles and projects. Auto Restorations was formed in 1973. 6 departments; Engineering (3 staff), Mechanical (8), Panel Shop (6), Paint Shop (3), Service Centre (2) and Administration (3). 17 international awards (client's vehicles). Customers: Domestic (60%) & International (40% pre-COVID), with international 60% by value.

George kindly arranged for a 1932 Alfa Romeo 8C2300 re-creation for display during lunchtime. It is a new car built from raw materials and does not use any donor parts from other vehicles. It was built from scratch to the same specifications as Alfa Romeo built in 1932. It has a straight-8 DOHC 2600cc with Roots supercharger, memini dual-throat carburettor, producing 185 bhp @ 4900 rpm and 4-speed gearbox and has a Zagato style body of aluminium panels on a steel frame. ## Constitution

It has been discovered the original (1996) “Green Book” version of the constitution held with the Incorporated Societies Register at the Companies Office did not recognise the role of Vice President. In the early 2000’s this role was established and has been operating since at least 2006. During this period (early 2000’s) record keeping was lacking due to change in Secretaries and for 2 years, no secretary. Other minor differences between our current operating “Yellow Book” version have been detected.

**MOTION: Formalise and submit changes made to the constitution (“Yellow” book) during the early 2000’s to the Companies Office and added to the Incorporated Societies Register.**

**ACTION:** Chris Butler (Secretary) & Tony Bartlett (Vice-President) review the two versions and (if any changes required from the upcoming Incorporated Societies Act 2021), executive ratify any modifications and submit constitution amendments at the 27<sup>th</sup> AGM (May 2022)

## Upcoming meetings

Meetings are planned with Minister of Transport, Waka Kotahi (NZ Transport Agency), Ministry of Transport, Motor Industry Training Organisation (MITO), Workforce Development Council (WDC), Low Volume Vehicle Technical Association (LVVTA) as needed on issues.

## Topics for Discussion / of Concern

- **Climate Change Commission:** Our sector is not a target. Nothing of immediate concern. Ensure ongoing supply of fuels. FoMC will make further submissions and continue to lobby for the preservation of the ongoing use of our vehicles
- **Extend WoF from 6 to 12 months for classic / heritage cars** (Jowett Car Club of NZ)  
Biggest issue is how do inspectors determine the difference between daily-runners and collectable vehicles (with very low milage between inspections). Is an issue that FoMC will continue working on. Daily runners will steadily exit the fleet and we will get to the point where collectables may have a different license type. Recording vehicle-kilometers-travelled (VKT) between WoF's is a good idea. A measured approach is required with ongoing dialog.
- **LED lighting** (Auckland Triumph Car Club): If a complete unit designed for vehicle, is OK. If modification not meeting the lighting standard, rejected. Particularly notable on undulating roads, where the beam is excessively and blindingly bright. Another issue, is indicator lights not clear due to bright daytime running lights. Manufacturers are now adjusting designs and the way they operate.
- **Incorporated Societies Bill (2021):** FoMC previously submitted on the (stalled) 2016 bill & everything we submitted on is included in this 2021 version. Roy described each of the pertinent aspects and reported everything in the bill makes sense with one exception – for financial reporting, the monetary size of the clubs appears too restrictive. Recommend increasing the definition of a small club from \$10,000 to \$50,000 turnover p.a., requiring a reviewer not an auditor. FoMC will make a submission.
